Dear County Cooperator,

Each year we review our anticipated costs and expected federal budget for the upcoming fiscal year to determine the overall impact of the program. This year we are only passing on a 3% overall increase to our cooperating county programs for FY19/20.

The billing process continues to be fully automated by FMMI. Standard-format invoices will be generated by the FMMI system and mailed on the fiscal quarter. We have no ability to apply equal quarterly payments, bill early or bill on a different cycle. And due to the manner in which various expenses are processed or held at the end of our Federal fiscal year, you can reasonably expect five or more invoices for each budget year which can and will extend beyond the close of the state FY, so please plan accordingly.

Enclosed you will find three copies of your counties Financial Plans (FP's). Once your county has approved and signed, please sign and return all 3 originals (wet signatures) of the FP. Once we have secured all signatures we will return an original copy for your files.

At a minimum we do require a "Letter of Intent" to ensure continued service beyond June 30th 2019, and cover the period before the documents are actually signed by you or the Board of Supervisors. Please keep the "Letter of Intent" in the format provided with all the information pertaining to your county. If you are signing and sending the Financial Plan prior to July 1st 2019, you won't need to send a Letter of Intent.

Work Plan:

This Work Plan is in reference to Cooperative Service Agreement No. 18-7306-0257-RA. USDA-APHIS-WS will administer an Integrated Wildlife Damage Management (IWDM) program in Lassen County. USDA-APHIS-WS will assist business/property owners, private citizens, and governmental agencies in protecting human resources, which include, but are not limited to, residents, property, livestock, crops, and natural resources from damage caused by predators, wild and feral animals, and other nuisance wildlife.

Financial Plan:

The cooperator will be billed quarterly by USDA-APHIS for actual costs incurred but will not exceed \$86,467.00 annually. An estimated itemization of expenses is listed below; however funds may be distributed between itemized categories at the discretion of USDA-APHIS-WS:
