SUBJECT: Agreement Between Lassen County and Cal Signal Corp

RECOMMENDATION: That the Board of Supervisors approve the Agreement with Cal Signal Corp and authorize the Public Works Director to sign.

DISCUSSION: The County is in the process of constructing Skyline Road Extension. Included within this construction contract is the installation of two signalized traffic signals, one at the intersection of State Route 36 and Skyline Road Extension and the other at the intersection of Johnstonville Road, Skyline Road East and Skyline Road Extension.

As part of the Cooperative Agreement with Caltrans, the County is responsible for providing the technical inspection and certification services for the installation of these two traffic signals. Since the County does not have qualified personnel to perform this work we have the need to hire a consultant. After a thorough research we were able to locate Cal Signal Corp who provides this service and is willing to complete this work for the County. This is a very specialized service with most consultants not wanting to travel to our area. Cal Signal Corp's bid is based upon an hourly rate along with per diem charges and mileage reimbursement for an estimated eight week construction timeline. This timeline is very conservative to allow for any potential delays during the construction/installation process. The personnel they assigned to this project is a retired Caltrans employee who will be traveling from Corning, California.

ALTERNATIVE: Not Approve.

FINANCIAL IMPACT: The maximum agreement amount is \$82,600.00. Funding is available in the Road Construction Budget 122-1222 where Federal STIP funding is available for reimbursement.
