# **COUNTY COUNSEL**

# CANNABIS AND HEMP

SUBJECT: Discussion and direction to staff regarding proposed changes to titles 1, 3, 6, 18, and 19 of the Lassen County Code to allow Industrial Hemp and certain Commercial Cannabis activities, where and under what conditions those land use activities might occur, to establish the tax rate for Industrial Hemp cultivation, to exempt Industrial Hemp cultivation from the County's right to farm protections, and to move the code provisions related to nuisance abatement from one title to another.

FISCAL IMPACT: Undetermined.

ACTION REQUESTED: Discussion and provide direction to staff.

CAO Egan informed the board that the purpose of the special meeting was to continue to discuss cannabis and hemp with all five Supervisors present. County Counsel Burns also stated that the original draft ordinance presented at a

previous meeting remained the same and changes to the ordinance had not occurred. Director of Planning and Building Services Maurice Anderson requested clear direction from the board pertaining to Title 18, testing and zoning. Extensive discussion was held regarding dispensaries, use permits and zoning. Fee structures and taxing were also discussed. The Board of Supervisors recommended amendments to the draft ordinance presented by County Counsel Burns. Additional discussion was held.
