Dear Mr. Egan and Members of the Board of Supervisors:

For several years, caregivers working through in-Home Supportive Services in Lassen County have been trying to reach an agreement with this Board for a memorandum of understanding that would allow them to be paid something above the minimum wage. Providers in almost every other county in California have, at some time, reached such an agreement. But never in this county.

In January of 2017, we agreed to submit our case to a fact finding panel, which included, along with our representative, a representative of your county and a neutral fact finder. That panel found that the union's position was fair, reasonable, and affordable. Despite that finding, Lassen County has chosen not to raise wages for Lassen caregivers, choosing instead to hold wages at the minimum wage.

In June of this year, the State of California passed AB 80, which modified the Welfare and Institutions Code to provide a penalty of 1% of total annual Maintenance of Effort for any county that, having reached impasse in negotiations and received a recommended resolution through factfinding, chooses to ignore that resolution and chooses not to reach an agreement with caregivers. That Any money collected under this provisionmoney is to be redistributed to the other counties. While the change to the WIC generally speaks to counties on a going forward basis, the language makes it clear that Lassen County's refusal to implement the findings of our 2017 factfinding is also included.

The State also, once again, provided additional resources to counties to make it even more cost effective to raise wages for county caregivers.

We want to make sure that you are aware that pursuant to WIC 12301.61.(g), if Lassen county fails to reach an agreement with SEIU Local 2015 by October 1, 2019, you will be subject to the 1% penalty. The Union further retains the right to again enter into negotiations with you. Should we reach the same outcome, the county could be subject to the penalty a second time.

We remain hopeful that we can reach an agreement, and that this county would rather bring resources to caregivers living in this county than to pay out additional funds, to be distributed to other counties. We look forward to hearing from you and to coming to a fair resolution on behalf of the people who live and work in Lassen County as caregivers, and for the vulnerable Lassen residents for whom they provide care.
