1:20 p.m. **PUBLIC HEARING: DESIGN REVIEW #2019-018, Joshua and Patricia Ballard.** The applicants are proposing a 3,200-square-foot accessory building that deviates from the roof overhang and siding requirements of Lassen County Code § 18.108.235. Deviation from these requirements is allowed upon approval by the Planning Commission through the Design Review process. The project site is zoned A-2-B-4 (Agricultural Residential District, 4 Acre Building Site Combining District) and its land use designation is "Rural Residential" in the *Janesville Planning Area, 1993*, and the *Lassen County General Plan, 2000*. The project site is located approximately 1.75 miles north of the intersection of U.S. Highway 395 and Standish-Buntingville Road at 713-265 Honey Girl Lane, Janesville, CA 96114. APN: 129-510-22.
