PUBLIC HEARING: DESIGN REVIEW #2019-024, JESSE & MANDYLEE

REEVES. The applicants are proposing a 320-square-foot shipping container single family residence that deviates from the roof pitch and roof overhang requirements of Lassen County Code § 18.108.235. Deviations from these requirements are allowed upon approval by the Planning Commission through the Design Review process. The project site is zoned A-2-B-4 (Agricultural Residential, 4 Acre Building Site Combining District) and has a land use designation of "Rural Residential" in the Janesville Planning Area, 1993, and the Lassen County General Plan, 2000.
