Storage Area Network Solution

BACKGROUND

The Lassen County Board of Supervisors approved the first centralized Storage Area Network (the SAN) in 2013. The current system is nearing hardware end-of-support.

ISD has been planning and saving for this upgrade. This is the most critical data system with the County's IT infrastructure.

SAN solutions save costs through centralization (sharing) of resources, ease of administration & data systems management for County Departments.

RECOMMENDATION

Respectfully recommend that the Board approve the purchase of a replacement SAN as outlined in the attached materials for an amount not to exceed \$155,000.

FISCAL IMPACT

The Server Storage System will be paid from the Internal Services Fund and the appropriation is included in the 2019-20 budget. Departments have already contributed their share of costs for the system through the annual ISD support charges.

The Information Services Department has obtained three mass purchasing contract quotes for each of the three system components listed below:
