<u>RECOMMENDATION</u>: That the Board of Supervisors approve the First Amendment to Agreement with Oilar's Agricultural Services and authorize the Public Works Director to sign.

<u>DISCUSSION</u>: The County currently has an Agreement with Oilar's Agricultural Services for providing trucking services on an "as needed" basis for various projects located throughout the County.

The County has been utilizing a couple of Oilar's trucks and operators on the Four Corners Road reconstruction project. This has been very beneficial to the County and we would like to be able to utilize them for the remainder of this project.

This First Amendment to the Agreement between Lassen County and Oilar's Agricultural Services will add an additional \$20,000 for the remainder of the term of the agreement. The revised Agreement will be in an amount of not-to-exceed \$45,000.
