Purchase of Taser Products from ProForce

Subject: Purchase of Taser devices, cartridges and holsters from ProForce.

## Discussion:

The Lassen County Sheriff's Office is required to annually qualify with their Tasers annually to be in compliance with department policy and recommendations of Axon, Incorporated (formally known as Taser). Axon recommends that everyone who carries a Taser discharges two cartridges annually. Personnel must meet other guidelines including a classroom training, training drills and qualify with the Taser to meet the standards required.

The Sheriff's Office is in need to purchase Taser Devices, cartridges and holsters to properly equip personnel. With the addition of personnel, we are required to purchase additional equipment. This purchase would include the purchase of five additional Tasers. Included in the purchase of Taser devices will be cartridges for certification training and holsters for the devices.

The Sheriff's Office has already exceeded the \$25,000.00 purchasing through a single vendor. As required by the Purchasing Policy, this request for the purchase must be approved by the Board of Supervisors.

Fiscal Impact: Sheriff's Office Budget Unit 130-0525 for \$9,233.69.

**Recommendation:** Approve the purchase and authorize the Sheriff's Office to purchase the requested items from ProForce.
