Subject:	Public Hearing for the 2019/2020 State Community Development Block Grant (CDBG) Program Notice of Funding Availability (NOFA)

Background:

The Community Development and Economic Development Allocations of the State CDBG Program is expected to publish a combined NOFA in January 2020. Eligible cities and counties may submit applications for CDBG funds under the NOFA. The maximum award limit is \$3,000,000.

The Department has received one possible application inquiry from Leavitt Lake Community Services District (LLCSD), to complete a water well renovation and paving, which are eligible activities under a Public Improvement Project. The Department has requested LLCSD to be present at this public hearing to make their request known to the Board of Supervisors.
