### **Background:**

# SECOND AMENDMENT TO AGREEMENT BY AND BETWEEN LASSEN COUNTY AND WEST HILLS HOSPITAL

THIS SECOND AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and West Hills Hospital (hereinafter "CONTRACTOR"), who agree as follows:

- 1. Recitals: This Second Amendment is made with reference to the following facts and objectives:
  - COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2017 through June 30, 2018, (the "Agreement") in which CONTRACTOR agreed to provide sub-acute inpatient services for chronic mentally ill adults and children.
- 2. Amendments: The parties agree to amend the Agreement as follows:
  - a. The parties desire to extend the term of the agreement for one additional year, FY 2019/20. Therefore, the first sentence of Section 2 is deleted and replaced with the following:
    - "The term of this agreement shall be for the period of July 1, 2017 through June 30, 2020."
  - b. The parties desire to extend the Maximum Contract Amount to include FY 2019/20. Therefore, Section B.2 is deleted and replaced with the following:
