Background:

**SECOND AMENDMENT TO AGREEMENT
BY AND BETWEEN
LASSEN COUNTY
AND
WEST HILLS HOSPITAL**

THIS SECOND AMENDMENT TO AGREEMENT ("Amendment") is made by and between LASSEN COUNTY ("COUNTY") and West Hills Hospital (hereinafter "CONTRACTOR"), who agree as follows:

1. **Recitals:** This Second Amendment is made with reference to the following facts and objectives:

COUNTY and CONTRACTOR have entered into a written Agreement for the term of July 1, 2017 through June 30, 2018, (the "Agreement") in which CONTRACTOR agreed to provide sub-acute inpatient services for chronic mentally ill adults and children.

2. **Amendments:** The parties agree to amend the Agreement as follows:

- a. The parties desire to extend the term of the agreement for one additional year, FY 2019/20. Therefore, the first sentence of Section 2 is deleted and replaced with the following:

"The term of this agreement shall be for the period of July 1, 2017 through June 30, 2020."

- b. The parties desire to extend the Maximum Contract Amount to include FY 2019/20. Therefore, Section B.2 is deleted and replaced with the following:
