ELECTION MANAGEMENT EQUIPMENT PURCHASE

SUBJECT: Replacement of Lassen County voting system, including all ballot tabulation and accessible equipment, with a system certified pursuant to the California Voting System Standards.

FISCAL IMPACT: \$241,287 from Fund/Budget Unit No. 100-0392

Maintenance-Computer Equipment. State and Federal Help America Vote Act (HAVA) funds will reimburse the county.

ACTION REQUESTED: 1) Authorize the Registrar of Voters permission to deviate from the County Purchasing Policy for a one-time purchase of new vote tabulation system; 2) approve and authorize the CAO to sign the System Purchase Order for elections Management Workstation (EMS) for the amount of \$9,727.89; and 3) approve and authorize the CAO to sign Sales Order Agreement for voting system tabulation and accessibility equipment in the amount of \$233,352.63 with election Systems & Software, LLC.

County Clerk - Recorder Julie Bustamante requested the Board to approve the Agreements to replace the Election Management System and to grant permission to a one time deviation from the county's purchasing policy to purchase a new vote tabulation system. County Clerk - Recorder Bustamante informed the Board there were only three certified vendors and all three were researched and visited. County Clerk - Recorder Bustamante stated that each county is different and had different needs and requirements. One size doesn't necessarily fit all. County Clerk - Recorder continued to discuss voting equipment, state requirements, the current extension of new equipment, and billing. County Counsel Burns explained to the Board the terms of the Agreement. Discussion was held.

HISTORIC COURTHOUSE RENOVATION DEMOLITION PHASE

SUBJECT: Bid award for Lassen County Historic Courthouse Renovation Project - Demolition Phase.

FISCAL IMPACT: Funding is available within the current 2019/2020 Fiscal Year (FY) Courthouse Square Construction Fund/Budget Unit No. 154-1541.

ACTION REQUESTED: 1) Award the contract to Bowen Engineering and Environmental, the lowest bidder meeting the specifications in the amount of \$493,000; and 2) authorize the Director of Public Works to sign the Agreement (agreement has been approved by County Counsel); and 3) authorize the Director of Public Works to authorize Change Orders up to a "not-to-exceed" amount of \$100,000 (approximately 20%) or a total contract not-to-exceed cost of \$593,000.

Deputy Director of Facilities Maintenance Peter Heimbigner informed the Board a bid award had been retained for the renovation action phase project. This would include initial demolition and abatement of hazardous material. Deputy Director Heimbigner briefly discussed the bid and reminded the Board this is within the budget for this segment. This is a state funded grant. There wouldn't be a reimbursement process to continue work as the funds had been drawn in advance. Deputy Director Heimbigner stated he had researched Bowen Engineering and Environmental and prior projects completed. Deputy Director Heimbigner stated they had done a sufficient job. Additional discussion was held.
