**Coronavirus Relief Funding and Realignment Backfill for Counties** 

The California Department of Finance (DoF) released initial information tonight regarding Coronavirus Relief Funds (CRF) and Realignment backfill funding for counties on a new DoF COVID-19 Information website.

The state is recommending parsing the county allocation of both funding sources in installments, with one-twelfth of the Realignment and one-sixth of the CRF funding due to counties in late July. To be eligible for both funding opportunities, counties are required to sign a CRF certification form and a "County General Fund COVID-19 Allocation" certification form, due by July 10, promising to comply with federal and state health orders and guidance related to the COVID-19 emergency.

CSAC is in continued conversation with the Governor and DoF on the above information and is strongly advocating for the state to release as much of these funds to counties as soon as administratively possible. CSAC is also advocating for clarity on the compliance issue. Without this critical funding, counties cannot continue to respond to the rising pandemic, increased need for safety net services, and the effects of the worst economic downturn in a century.

The <u>new site</u> includes a slightly-modified list of <u>CRF allocations to counties</u>, which were updated with new population statistics since being published in the May Revision. CSAC is continuing to consult with the DoF to develop an allocation for the Realignment backfill funding as directed by the State Budget Act of 2020.

## **COVID-19 Information**

To respond to, and provide support for, the novel coronavirus, a disease known as COVID-19, the state and federal government has provided resources to support state and local government, respond to the public health crisis, encourage recovery, and support vulnerable Californians. This site provides information related to funding to address COVID-19 and support the state's recovery. Please visit this website frequently as information is regularly updated.

#### Allocations for Direct Disaster Response Operations

The state has used funds available pursuant to Government Code section 8690.6 and Control Section 36.00 to support the state and local emergency response to COVID-19. The Allocation Summary for COVID-19 (2019-20 Fiscal Year) can be accessed here along with notification letters by date.

#### Coronavirus Relief Fund Allocations for Cities and Counties

Based on the state's population, California received a total of \$15.3 billion Coronavirus Relief Funds (CRF) provided in the federal CARES Act, with \$9.5 billion paid to the state and \$5.8 billion paid to cities and counties with populations over 500,000. The Budget authorizes the Department of Finance to allocate \$1.8 billion of the state's share of CRF to counties and cities. ### County General Fund COVID-19 Allocations

The Budget includes \$750 million to provide support for counties experiencing revenue losses for realigned programs as a result of COVID-19. The link above provides the allocation for each county of the initial funding included in the Budget Act and the required certification to access these funds. #### Federal Stimulus

The federal government has provided temporary federal funding to support the state's response to the COVID-19 pandemic. This funding was made available through four federal bills.   - b. Use the funds in accordance with all applicable provisions of subdivision (d) of Control Section 11.90 of the Budget Act of 2020.
  - c. Report on expenditures and summarize regional collaboration and non-duplication of efforts within the region by September 1, 2020, and return any funds that are unspent by October 30, 2020 (unless extended by the Department of Finance based on reported expenditures to date), and repay the state for any cost disallowed after federal review.
  - d. Retain records to support reported COVID-19 eligible expenditures and participate in audits as outlined by the federal government and State.
