RE: Proposed Music Festival at 465-565 Elysian Valley Road in Janesville (APN 129-020-012)

It has come to this Department's attention that you are planning to host a music festival called "The Great Awakening" (<https://www.thegreatawakeningofficial.com/>) from June 18-21, 2021, at your property at the above address. Previously, on September 15, 2020, this Department emailed prospective event coordinator Gino Meyer at [gino.meyer97@hotmail.com](mailto:gino.meyer97@hotmail.com) (attached) stating that if you did want to host a music festival at said property, you would have to submit a use permit application, and ultimately have it approved by Lassen County. Lassen County Code Section 18.102.020(a)(5) allows for "[c]ircus, open-air fair, carnival, or similar temporary assemblage of large amount of people, provided no permanent structure is constructed" by use permit in all zoning districts. The Department's email to you also stated that said use permit application would also require an initial study application pursuant to the California Environmental Quality Act. Since you have not secured a use permit for your proposed music festival event, if said proposed music festival did occur during the above dates, it would be in violation of the Lassen County Code.

Please find the use permit application and process form, along with an initial study application, attached with this letter. A complete use permit application must include information required by Chapter 5.12 of the Lassen County Code, which is titled "Outdoor Festivals" (also attached). Please also be aware, however, that the environmental review process (and the use permit process itself) can take several months or longer. Therefore, **you will not be able to secure the requisite use permit in time to host your proposed music festival during the above June dates.** In light of these facts, you must cancel your proposed music festival until you are able to secure the appropriate use permit from Lassen County (if you are able to secure a use permit at all), as well as any other applicable permits.

To that end it should be noted, your property is enrolled in the Williamson Act (California Land Conservation Act of 1965). Uses allowed on properties in the Williamson Act are generally restricted to those agricultural uses that are necessary for the production of food and fiber. For this reason, if you did apply for a use permit, this Department would recommend against the issuance of said use permit, as the land is restricted to the production of food and fiber. Use permits are generally approved or denied by the Lassen County Planning Commission, but in some cases, require the approval of the

Lassen County Board of Supervisors. It is unclear in the absence of an application, what additional permits will be required.


If you choose to host your proposed music festival without first securing the requisite use permit, please note that there are several enforcement actions that Lassen County may take against you. These may include a civil injunction, a notice of noncompliance recorded against your property, administrative citations, misdemeanor penalties, temporary restraining orders, and/or the abatement of civil nuisances, among other actions.

In addition, and as detailed in the attached letters dated May 11, 2010, and August 2, 2012, please be aware that you are not authorized to conduct commercial weddings or gatherings at the above property, nor use the existing 60' x 60' structure on the property to host similar commercial events. Said building received an exemption from the requirement to secure a building permit under the premise that it would be used solely for agricultural purposes, as a livestock and agricultural equipment barn.

Again, this Department is informing you that your proposed music festival must be canceled until you are able to secure the appropriate use permit from Lassen County (if you are able to secure said use permit at all). As stated above, the event in question is scheduled to take place from June 18 to 21, 2021. The website for the event (<https://www.thegreatawakeningofficial.com/>) indicates that tickets are currently being sold. Please notify this Department by May 10, 2021, regarding your intentions as they pertain to this matter.

Hi Gino,

Sorry for the delayed email. APN 129-020-12 is zoned E-A-A-P (Exclusive Agricultural Agricultural Preserve Combining District), along with the majority of APN 129-650-16, which appears to be part of the same legal parcel. The first step toward your proposed music/camping event on this parcel would be submittal of a use permit application (\$1,350 application fee – attached with process information) by the property owner of record, pursuant to Lassen County Code, Section 18.102.020(5) - [http://qcode.us/codes/lassencounty/view.php?topic=18-18\\_102-18\\_102\\_020](http://qcode.us/codes/lassencounty/view.php?topic=18-18_102-18_102_020). This application should include as many details of the proposed event as possible, including:

- The name, mailing address, email address, and telephone number of the applicant;
- The location, Assessor's Parcel Numbers (APNs), and legal description of the premises where the outdoor festival is proposed to be conducted, including all lands to be used for parking or other uses incidental to the outdoor activity. The applicant shall submit proof of ownership of the premises, if the sole owner, or the written consent of all owners thereof for the proposed use;
- The date or dates and the hours during which the festival is to be conducted;
- An estimate of the maximum number of spectators, participants and other persons expected to attend the outdoor festival for each day it is conducted;
- A detailed explanation of the applicant's program and plans to provide security protection, water supply, food supply, sanitation facilities, medical facilities and services, vehicle parking space, vehicle access and on-site traffic control, and if it is proposed or expected that spectators or participants will remain at night or overnight, the arrangements for illuminating the premises and for camping or similar facilities, applicant's plans to provide for number of spectators in excess of the estimate, and provisions for cleanup of the premises and removal of rubbish after the event has concluded;
- A detailed explanation of the applicant's plan for policing the activity with particular emphasis on the control and prevention of alcoholic and drug consumption;
- All loudspeakers and sound equipment to be used and the intensity of the sound, in decibels, at the boundaries of the premises;
- Such other information pertinent to the outdoor festival as any county officer finds necessary and requires in order to determine whether or not the permit should be granted and, if granted, the conditions of such permit;
- A consent to the entry at any time in the course of his duties of any peace officer, the Lassen County engineer state forestry employees or fire wardens, sheriff, county health officer and any other county officer in the performance of his duties.

An Initial Study application (\$2,000 application fee - attached) would also be submitted with the use permit application to determine the type of environmental document required for the proposed project. If an Environmental Impact Report is required, the department's fee is \$2,619 plus either: (1) a preparation charge based on actual cost (time and materials) exceeding the application fee if the document is prepared and/or reviewed by county staff; or (2) an administration fee equal to ten percent of the total contract costs if the document is prepared under contract to the county. (Lassen County Planning fees can be found here: [http://qcode.us/codes/lassencounty/view.php?topic=3-3\\_18-3\\_18\\_020&frames=on](http://qcode.us/codes/lassencounty/view.php?topic=3-3_18-3_18_020&frames=on).) Depending on the type of environmental document required, this process could take between 6 months to a year, or longer if the project is put on hold for any reason.



During the use permit process, affected governmental agencies will be noticed of the project and given opportunity to comment and condition approval of the potential use permit. Permits issued by other agencies may be required. The application will also be considered by the Lassen County Planning Commission at a public hearing. Affected governmental agencies and surrounding property owners will be notified of said hearing and invited to submit comments/attend the meeting. Additional information about the proposed use, necessary to processing the application, may be requested by staff at any time throughout the use permit process. Please let us know if you have any other questions at this time.

The following information is intended to provide a generalized description of the Use Permit process in Lassen County.

### APPLICATION

In accordance with the California Environmental Quality Act (CEQA), most Use Permit applications considered by Lassen County must first undergo an established environmental review procedure. The first step in the environmental review procedure is the Initial Study. An Initial Study Application is made by the completion and submittal to the Lassen County Planning and Building Services Department of an Initial Study (Appendix A) a Use Permit Application, a plot plan of the proposed project, and any additional information requested by the Department of Planning and Building Services for a complete and acceptable application. Filing fees are as follows: \$2,000.00 for Initial Study Review and \$85.00 for Environmental Health, plus a separate fee of \$75.00, made payable to the CSU Chico Research Foundation, for an archaeological records search (NOTE: Additional project review fees may be required by the California Archaeological Inventory Center). Class I \$742.00, applies to Use Permits for signs and single-family residences; Class II \$1,350.00, applies to Use Permits not categorized as Class I or Class III; Class III \$1,350.00, applies to Use Permits for proposed production projects to generate electrical power for private or public utility uses, as well as exploratory and production wells, or otherwise to supply an energy resource by any means for sale or use other than use strictly by the applicant; transmission facilities including power lines and pipelines; projects in which a major component of the operation is the handling or disposal of solid or hazardous wastes, or the handling of hazardous or toxic materials; cannabis dispensary and testing pursuant to section 18.108.045 and 18.108.046.

All fees are for the processing of applications and are non-refundable after processing has commenced. It should be noted that some Use Permit applications (for example, signs that are within the limitations of the existing zoning district and sign regulations of the Lassen County Code, Title 18) are exempt from the environmental review requirements of CEQA. If a preliminary review of a project proposal by the Department of Planning and Building Services reveals that an exemption to CEQA does apply, then the fee for the Initial Study Application can be waived and/or returned to the applicant. However, if it is determined that the project is exempt from environmental review, and your project is ultimately approved, a \$200.00 fee for filing the Notice of Exemption with the County Clerk's Office will be required.

A complete and accurate set of application materials is of utmost importance for timely processing. A clear and detailed plot plan is essential. Applicants should consider supplementing their application with color photographs, or any other materials that would assist reviewers in gaining a better understanding of the project.

### ENVIRONMENTAL REVIEW - PROCEDURE

In Lassen County, the Director of Planning and Building Services has been designated as the Environmental Review Officer (ERO) as per Lassen County Resolution No. 01-043. In general, the duties of the ERO are to coordinate the environmental review procedures, prepare Initial Studies, recommend environmental findings to the Lead Agency (the Planning Commission or, ultimately, the Board of Supervisors), prepare all applicable environmental documents, conduct public meetings, and keep the County's environmental review guidelines in continual compliance with CEQA.

The ERO conducts a preliminary review of all project applications to determine, within thirty (30) days, whether the application is complete and/or whether the proposed project is exempt from CEQA. Once the application has been accepted as complete, and not found to be exempt from CEQA, an Initial Study is

If you believe your project will have *no effect* on fish and wildlife, you may contact the California Department of Fish and Wildlife to discuss an exemption from the fees. IMPORTANT NOTE: Even if your project is approved by the County, the project is not operative, vested, or final, and any local permits issued for the project are invalid if the fees are not paid.

### APPEALS

Following the action taken by the Planning Commission at the public hearing, there is a ten (10) day appeal period during which any person may appeal decisions of the Planning Commission. Appeals may address approval or denial, and/or any conditions to approval. Any appeals must be made in writing to the Lassen County Board of Supervisors through the County Clerk's Office. Appeals of Planning Commission decisions are heard by the Board of Supervisors. Decisions of the Board of Supervisors are final. There is a \$500.00 fee for all appeals.

### FINALIZATION OF THE USE PERMIT PROCESS

If a Use Permit is approved and no appeals are filed within the ten (10) day appeal period following the approval, the project applicant will be issued an official Use Permit. The official Use Permit will identify the use that has been approved and any applicable conditions to said approval.

In the case that the Use Permit Application has been denied, the applicant will receive a letter informing them of the denial and the findings leading thereto. If a Use Permit is not used within one year after approval, that is, if the specific use for which the Use Permit was issued is not effectuated within one year from the issuance of the official Use Permit, then the Use Permit will be considered null and void. If necessary, the permittee may submit a letter to the Planning Commission prior to the expiration date requesting an extension of the one-year expiration time. Extensions may be granted for up to one year, and a maximum of two extensions of time may be allowed. Extension requests are considered at the next regularly scheduled Planning Commission meeting. There is a \$238.00 fee for all extension requests. In the case that the conditions of a Use Permit are not met, or if the use becomes something other than the use as approved under the subject Use Permit, the Planning Commission will take action to revoke the permit and terminate the use.

### AUTHORIZATION TO OPERATE

On the effective date of an approved use permit, the permittee may proceed with development of the use subject to the conditions of approval, but shall not be authorized to operate the use until a \$200.00 fee has been paid and a written Authorization to Operate has been issued by the Department of Planning and Building Services. An Authorization to Operate will be issued when the permittee has demonstrated compliance with conditions of approval, and has submitted to the Department of Planning and Building Services a written request for Authorization to Operate (§18.112.080 Lassen County Zoning Ordinance).

The Department of Planning and Building Services staff would be happy to help you through the Use Permit process, and refer you to other public agencies that may be involved in your particular project. Title 18 ZONINGChapter 18.102 GENERAL PROVISIONS AND EXCEPTIONS**18.102.020 General district uses.**

(a) The following uses may be permitted in all districts, except O-S, O-D and O-H districts, or as otherwise specifically prohibited, subject to securing a use permit in each case:

- (1) Surface mining as provided for in Chapter 9.60 of this code;
- (2) Excavation of minerals, earth or construction materials from the surface of the earth in amounts exceeding one thousand cubic yards, except that:
  - (A) A use permit shall not be required for earth-moving or excavation activities when such are a necessary and integral part of a construction project for which the following conditions are met:
    - (i) All necessary grading and building permits have been obtained, and
    - (ii) No excavated material is removed from the construction site, or
    - (iii) When the excavation of material has been fully considered and addressed by the approving agency in the course of permitting the project generating the material(s), and when the disposition of the excavated material has been fully considered and addressed by the approving agency in the course of permitting the project receiving the material(s);
  - (B) A use permit shall not be required for earth-moving or excavation activities when such are a necessary and integral part of an agricultural operation, and the excavated or surplus material is used for agricultural purposes on agricultural lands;
- (3) Exploratory wells for geothermal, gas and oil resources;
- (4) Production wells and projects involving geothermal, gas and oil resources. Production wells and projects may be considered with the exploratory phase as one permit if sufficient information is submitted to describe the proposed production phase of the project;
- (5) Circus, open-air fair, carnival, or similar temporary assemblage of large amounts of people, provided no permanent structure is constructed.

(b) The following uses may be permitted in all districts, subject to the below-listed stipulations:

- (1) Public utility, electric, gas, water, oil and telephone transmission and distribution lines shall be permitted in all districts without the necessity of first obtaining a use permit; provided, that maps showing proposed routes of such transmission lines, together with a written statement of approximate structure heights and right-of-way widths, shall be submitted to the planning commission, and routes mutually acceptable to the planning commission and utility agencies concerned shall be determined in writing. The planning commission shall make findings concerning the consistency of such proposed routes with the general plan;
- (2) Nonpublic utility lines for transmission or distribution of electricity, gas, water, oil, gasoline, telephone, television, or other utility may be permitted in all districts; provided that, in any case necessitating right-of-way acquisition, a use permit shall be secured in each case prior to such acquisition. Each use permit application shall be accompanied by plans, showing on current U.S.G.S. Quadrangle or equivalent maps, the right-of-way route proposed, and written statements or scaled drawings, or both, the proposed right-of-way width, structure types and heights, burial depths and such other information as may be deemed necessary by the planning commission;
- (3) Except as otherwise specified in this title, the sale and service of alcoholic beverages shall be permitted by right if incidental to the operation of a restaurant or delicatessen. (Ord. 467-R § 3, 1994; Ord. 467-Q § 19, 1994; Ord. 467 § 39, 1984).

Title 5 BUSINESS LICENSES AND REGULATIONS**Chapter 5.12 OUTDOOR FESTIVALS****5.12.010 Defined.**

For the purpose of this chapter “outdoor festivals” means and includes any outdoor gathering of individuals for the purpose of participation in rock dances and similar musical and/or theatrical type performances which are of a periodic nature and to which the public is admitted with or without the payment of admission charges. (Ord. 337-A § 2-1, 1976; Ord. 337, 1959)

**5.12.020 License—Application and fee.**

(a) It is unlawful for any individual, partnership or corporation to operate, maintain, conduct, advertise, sell or furnish tickets or other types of written authority for admission to an outdoor festival in the unincorporated area of Lassen County unless he, they or it first obtains a license from the county to operate or conduct such festival.

(b) Application for a license to conduct an outdoor festival shall be made in writing to the board of supervisors of Lassen County, accompanied by a nonrefundable application fee of one hundred dollars and filed with the county license collector as designated by Ordinance 337, Section 3, codified at 5.04.020, and shall contain the following information:

(1) The name, age, residence, mailing address and telephone number of the applicant. If the application is made by a partnership, the names and addresses of all general partners shall be included. If the applicant is a corporation, the application shall be signed by the president and attested to by the secretary thereof and shall contain the names and addresses of all corporate officers and a certified copy of the articles of incorporation shall be attached to the application. The address and telephone number of the principal place of business of the applicant shall also be included in the application;

(2) The location and legal description of the premises where the outdoor festival is proposed to be conducted, including all lands to be used for parking or other uses incidental to the outdoor activity. The applicant shall submit proof of ownership of the premises for the written consent of all owners thereof for the proposed use;

(3) The date or dates and the hours during which the festival is to be conducted;

(4) An estimate of the maximum number of spectators, participants and other persons expected to attend the outdoor festival for each day it is conducted;

(5) A detailed explanation of the applicant’s program and plans to provide security protection, water supply, food supply, sanitation facilities, medical facilities and services, vehicle parking space, vehicle access and on-site traffic control, and if it is proposed or expected that spectators or participants will remain at night or overnight, the arrangements for illuminating the premises and for camping or similar facilities, applicant’s plans to provide for number of spectators in excess of the estimate, and provisions for cleanup of the premises and removal of rubbish after the event has concluded;

(6) A detailed explanation of the applicant’s plan for policing the activity with particular emphasis on the control and prevention of alcoholic and drug consumption;

(7) All loudspeakers and sound equipment to be used and the intensity of the sound, in decibels, at the boundaries of the premises;

(8) The names and addresses of all persons who will act as security guards during the outdoor festival;

(9) Such other information pertinent to the outdoor festival as any county officer finds necessary and requires in order to determine whether or not the license should be granted and, if granted, the conditions of such license;

(10) A consent to the entry at any time in the course of his duties of any peace officer, the Lassen County engineer state forestry employees or fire wardens, sheriff, county health officer and any other county officer in the performance of his duties. (Ord. 337-A § 2-2(A), 1976; Ord. 337, 1959).

**5.12.030 License application—Documents.**



At the time of filing an application for a license for an outdoor festival the applicant at the same time, also shall file:

H-1

(1) Four copies of white background prints of a map drawn to scale, showing:

(A) The location of the property concerned,

(B) The location of all highways, streets, alleys, lots and parcels of land within seven hundred feet of the exterior boundaries of the proposed use,

(C) The location of the parking area and of all other areas to be used for other uses incidental to the outdoor festival,

(D) All interior accessways,

(E) Access to the property,

(F) The location and detailed plans of all buildings and structures on the premises or to be erected, including the bandstand, stage, or other facility for performers,

(G) The location of all loudspeakers,

(H) The location of all toilet, medical, drinking and other facilities,

(2) A certified list as shown on the latest available assessment roll of the county of the names and addresses of all persons to whom all property is assessed within five hundred feet of the exterior boundaries of the proposed use;

(3) A document showing that the applicant is the owner of the premises or an agreement in writing signed by the owner permitting such use of the premises and the filing of the application;

(4) The agreements or contracts which show what doctors, first-aid attendants and ambulances will be available at the outdoor festival;

(5) An agreement signed by the applicant that, within seventy-two hours after the conclusion of the outdoor festival, he will clean up the premises and remove all trash and debris therefrom. Such agreement shall be secured by an undertaking or assignment of savings and loan shares or certificates or both in a total amount of not less than five thousand dollars;

(6) If such outdoor festival is not exclusively devoted to religious worship and music incidental thereto, an agreement signed by the applicant and by the owner of the subject premises that they will reimburse all owners and occupants of property adjoining the subject premises for all damages of any kind to such owners or occupants or to their property caused by the applicant, owner of the subject premises, or by any person attending the outdoor festival, which damage would not have occurred had the outdoor festival not been held, and an undertaking, policy of insurance, or agreement accompanied by the assignment of savings and loan shares or certificates, or a combination of any two or all of the above as provided in this section. (Ord. 337-A § 2-2B, 1976; Ord. 337, 1959).

#### **5.12.040 Undertaking.**

The undertaking required by subsection (6) of Section 5.12.030 shall be for the benefit of the county and all persons to whom the licensee or owner may become liable because of the agreement required by subsection (6) or arising from the conduct of the licensee of the outdoor festival. (Ord. 337-A § 2-2B(l), 1976; Ord. 337, 1959).

#### **5.12.050 Insurance policy.**

The insurance policy required by subsection (6) of Section 5.12.030 shall insure the licensee and owner of the subject property against all liability incurred by them or either of them to the county or to any person, which liability arises pursuant to the agreement required by subsection (6) of Section 5.12.030 or arising from the conduct of the licensee of the outdoor festival. (Ord. 337-A § 2-2B(2), 1976; Ord. 337, 1959).

#### **5.12.060 Satisfaction of judgment.**

An applicant for a license for an outdoor festival who deposits with the tax collector and assigns to the county savings and loan certificates or shares in lieu of, or in addition to, the undertaking or policy of insurance required by subsection (6) of Section 5.12.030, also, at the same time shall file with the tax collector an agreement in writing in which he agrees that the county may, satisfy either in whole or in part, from such certificates or shares, any final judgment or any judgment



upon which execution may issue the payment of which is, or would have been guaranteed by the undertaking required by this chapter. (Ord. 337-A § 2-2B(3), 1976; Ord. 337, 1959).

#### **5.12.070 Amount of undertaking, insurance or deposit.**

The undertaking, policy of insurance, and savings and loan certificates or shares assigned shall each be in such an amount that the total shall not be less than fifty thousand dollars. (Ord. 337-A § 2-2B(4), 1976; Ord. 337, 1959).

#### **5.12.080 Applicability.**

If an application is filed prior to August 3, 1976, for a license to conduct an outdoor festival, it shall be valid and treated as if it were filed after August 3, 1976, if in all respects it complies with the provisions of this chapter. (Ord. 337-A § 2-2B(5), 1976; Ord. 337, 1959).

#### **5.12.090 Application—Pending.**

(a) If, on August 3, 1976, there is pending an application for a license required by Ordinance 337, as codified in Chapter 5.04 of this code, as it read immediately prior to August 3, 1976, and if the activity for which such license is applied for is an outdoor festival, such application may be treated as an application pursuant to the provisions of this chapter. Such application shall be deemed sufficient if it complies with Section 5.04.010 except the applicant also shall supply such information and such documents as are required by this chapter and are requested by any county officer including the board of supervisors.

(b) Such application shall be filed with the Lassen County license collector at least sixty days prior to the time indicated for the commencement of the planned activity. The license collector shall review and submit such application to the board of supervisors and no license shall be issued by the license collector until that officer is authorized to do so by order of the board of supervisors at a regular meeting of the board. (Ord. 337-A §§ 2-2B(6), 2-2C, 1976; Ord. 337, 1959).

#### **5.12.100 Hearing, investigation and report.**

Upon receipt of a complete application and the application fee, the license collector shall request the board of supervisors to set a time and date for a public hearing and the board of supervisors shall set the application for a public hearing at a regular meeting of the board, not less than fifteen nor more than thirty days thereafter, and shall give not less than ten days' written notice thereof to the applicant. The clerk of the board of supervisors shall give notice of the hearing and copies of the application to the sheriff, the county health officer, the director of public works and the planning administrator, who shall investigate the matter and report in writing to the board of supervisors not later than the time set for the hearing, with appropriate recommendations concerning the activity. (Ord. 337-A § 2-3, 1976; Ord. 337, 1959).

#### **5.12.110 Hearing—Procedure.**

(a) The board of supervisors shall consider the documentary and testimonial evidence of witnesses presented at the hearing, including all reports of investigation, and shall thereafter grant the license without conditions or with conditions which must be met, including security required from the applicant as a guarantee that the conditions will be met, before a license is granted.

If conditions are imposed by the board, the applicant shall furnish or cause to be furnished to the license collector proof that all conditions have been met, and the required security has been given, before the license may be issued by the license collector.

(b) Security required by the board of supervisors may include the posting of an indemnity bond and/or a performance bond in favor of the county in connection with the operation of a public outdoor festival as defined in this chapter. Such bond or bonds shall be prepared by a corporate bonding company authorized to do business in the state by the Department of Insurance, in an amount determined by the board of supervisors of Lassen County. The bond or bonds shall indemnify the county, its agents, officers, employees and the board of supervisors of the county against any and all loss, injury and



damage of any nature whatsoever arising out of, or in any way connected with, said outdoor festival and shall indemnify against loss, injury and damage to both person and property. H-1

The board of supervisors may also require that the applicant provide a corporate surety bond prepared by a corporate bonding company authorized to do business in the state of California, indemnifying Lassen County and the owners of property adjoining the outdoor festival site for all costs necessitated by such activity to clean up and/or remove debris, trash, garbage or other waste from, in and around the premises. Such bond shall be in an amount determined by the Lassen County board of supervisors as in its discretion will adequately provide for such indemnification.

The board of supervisors may also require that the applicant provide a corporate surety bond by a corporate bonding company authorized to do business in the state of California securing the performance of each condition imposed as to the issuance of the license. All such conditions shall appear on the license. (Ord. 337-A § 2-4(A), 1976; Ord. 337, 1959).

#### **5.12.120 Potable water required.**

(a) The licensee shall provide drinking water which the health officer first finds potable and of acceptable quality for a public water system in accordance with applicable provisions of law by providing drinking fountains as follows:

- (1) One drinking fountain for the first one hundred persons;
- (2) Two drinking fountains for more than one hundred but less than five hundred persons;
- (3) One additional drinking fountain for each additional five hundred persons or fraction thereof.

(b) If the health officer finds that lesser or different facilities are sufficient instead of the above, the licensee shall provide such facilities. (Ord. 337-A § 2-4(B)(1), 1976; Ord. 337, 1959).

#### **5.12.130 Sanitary facilities.**

The licensee shall provide at least one water closet and one urinal for every two hundred males and one water closet for every one hundred females, or major fraction of such number permitted to attend, unless the health officer finds that a lesser number is sufficient in which case he shall provide such number. If a compartment contains one water closet and one urinal the licensee may count it as one water closet or as one urinal but not as both. The sanitary facilities shall first be approved by the health officer. The health officer shall approve such facilities if he finds that they comply with applicable state and county health regulations.

The licensee shall provide one lavatory for each two fixtures required. Where both sexes are admitted, the sexes shall be assumed to be equally divided. (Ord. 337-A § 2-4(B)(2), 1976; Ord. 337, 1959).

#### **5.12.140 Parking.**

Every premises on which an outdoor festival is conducted shall have on such premises or contiguous thereto automobile storage spaces equal to one fifth of the number of persons which the license permits to attend the outdoor festival unless the county engineer finds that a smaller number is sufficient in which case the licensee shall provide such lesser number. The automobile parking spaces shall be graded, marked and separated by a physical barrier from the area where the patrons will watch the performance. At all times between one hour before the beginning of the outdoor festival and one hour after its termination the licensee shall provide parking attendants at all entrances, exits and within the parking lots. (Ord. 337-A § 2-4(B)(3), 1976; Ord. 337, 1959).

#### **5.12.150 Security guards.**

(a) At every outdoor festival one male employee approved by the sheriff for each two hundred persons which the license permits to attend, whether actually present or not, shall be constantly in attendance during the entire time the outdoor festival is in progress, and shall devote his entire time and attention to keeping order, and observing and enforcing all applicable statutes and ordinances including this chapter.

(b) The board of supervisors shall approve a security guard unless it finds, as a ground of disapproval, any such person has been convicted of any of the following offenses within the last five years in a court of competent jurisdiction:



- (1) Any crime requiring registration under Section 290 of the Penal Code;
- (2) Any violation of Chapter 7.5 (beginning with Section 311) of Title 9, Part 1 of the Penal Code; or
- (3) Any violation of Chapter 7.6 (beginning with Section 313) of Title 9, of Part 1 of the Penal Code; or
- (4) Any violation of Paragraphs (a), (b), or (d) of Section 647 of the Penal Code; or
- (5) Any violation of Section 315, or 316 or 318 of the Penal Code; or
- (6) Any offense involving the use of force or violence upon the person of another; or
- (7) Any offense involving the maintenance of a nuisance in connection with the same or similar business operation. (Ord. 337-A § 2-4(B)(4), 1976; Ord. 337, 1959).

#### **5.12.160 Fire protection.**

The licensee shall provide all fire protection and fire safety measures as the State Division of Forestry and chief of any fire protection district within whose jurisdiction the license is sought finds necessary to protect those attending the outdoor festival. (Ord. 337-A § 2-4(B)(5), 1976; Ord. 337, 1959).

#### **5.12.170 Lighting.**

If the hours during which the outdoor festival can be held as provided in the license are such that any portion thereof is between sunset of one day and sunrise the following day or the license permits any participant to remain overnight, the licensee shall provide such lighting, including the location of all light standards and electrical switches as the county engineer finds necessary for public safety and welfare. (Ord. 337-A § 2-4(B)(6), 1976; Ord. 337, 1959).

#### **5.12.180 Cleanup.**

Within seventy-two hours after the end of an outdoor festival the licensee shall clean up the premises and remove all trash and debris therefrom. (Ord. 337 337-A § 2-4(B)(7), 1976; Ord. 337, 1959).

#### **5.12.190 Communications system.**

The licensee shall install and, at all times during which the outdoor festival is in progress, maintain an emergency communications system which both the sheriff and Division of Forestry and chief of any fire protection district within whose jurisdiction the license is sought adequate for fire and police protection. (Ord. 337-A § 2-4(B)(8), 1976; Ord. 337, 1959).

#### **5.12.200 Dates and hours.**

The licensee shall operate the outdoor festival only on those days and during the hours specified on the license. (Ord. 337-A § 2-4(B)(9), 1976; Ord. 337, 1959).

#### **5.12.210 Number of participants.**

The licensee shall not admit, and shall prevent the entrance of, to the premises on which the outdoor festival is held, any person who does not possess a ticket, except a peace officer or other public officer in the performance of his duties. Admission shall be by ticket only. The licensee shall not sell, give, or distribute a greater number of tickets than the number which the license permits to attend. The licensee shall not admit any person to an outdoor festival if such admission would result in a greater number of persons present than permitted by the license. (Ord. 337-A § 2-4(B)(10), 1976; Ord. 337, 1959).

#### **5.12.220 Advertising.**

A person shall not advertise or announce by any means or medium, including but not confined to pamphlets, handbills, newspapers, radio and television, the holding of an outdoor festival prior to the granting of a license permitting such outdoor festival. The licensee or other person shall not print, distribute, broadcast, or use any such advertising or announcement, or any other advertising of the outdoor festival which has not first been approved by the board of supervisors. The board of supervisors shall approve such advertising if it states that admission is by ticket only, if all statements are true and if there is no statement which might imply any conclusion contrary to fact. (Ord. 337-A § 2-4(B)(11), 1976; Ord. 337, 1959).

#### **5.12.230 Alcohol or drugs.**

A person shall not enter, be, or remain on any part of the premises on which an outdoor festival is conducted while in the possession of, consuming, using, or under the influence of, any alcoholic beverage or drugs. The licensee shall not permit any such person to enter or remain upon the licensed premises. (Ord. 337-A § 2-4(B)(12), 1976; Ord. 337, 1959).

#### **5.12.240 Dust control.**

The licensee shall use such methods of dust control as are approved by the health officer. The health officer shall approve such methods if he finds that such methods will prevent the arising of dust to an extent which may endanger the public health or safety. (Ord. 337-A § 2-4(B)(13), 1976; Ord. 337, 1959).

#### **5.12.250 Accessways.**

The licensee shall provide all exterior and interior accessways which the sheriff and county engineer find necessary for the use of participants at the festival. All exterior and interior accessways shall be clearly delineated by means of curbs or buffers on the ground. A person shall not occupy any such accessway except for the purpose of access or to cross the same. (Ord. 337-A § 2-4(B)(14), 1976; Ord. 337, 1959).

#### **5.12.260 Food and beverages.**

In selling, preparing, delivering, or serving food or beverages, or both, all persons shall comply with the California Restaurant Act, Chapter 11 (beginning with Section 28600) of Division 21 of the Health and Safety Code of the state of California. (Ord. 337-A § 2-4 (B)(15), 1976; Ord. 337, 1959).

#### **5.12.270 License—Issuance.**

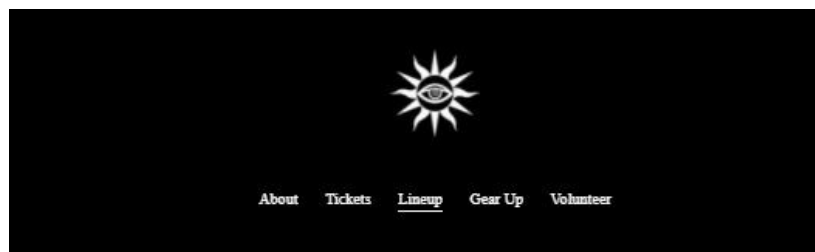
Upon determining that the board of supervisors has ordered the issuance of the license pursuant to Sections 5.12.110 through 5.12.260, and that the conditions, if any, imposed by the board, have been complied with by the applicant, the license collector shall collect a license fee of five hundred dollars per day for each day for which the festival is scheduled and he shall issue a license to the applicant for the specific location authorized for the festival and for the specific days for which the festival is authorized. (Ord. 337-A § 2-5, 1976; Ord. 337, 1959).

#### **5.12.280 Exemptions from application and fee payments.**

A neighborhood or community benefit organization, organized for charitable, religious or eleemosynary purposes, shall be exempt from paying the application and license fees provided for in this chapter, provided that net proceeds from any such activity do not inure to the benefit of any private persons, partnership or corporation. (Ord. 337-A § 2-6, 1976; Ord. 337, 1959).
