SUBJECT: Resolution Certifying County Maintained Road Mileage for 2020

RECOMMENDATION: That the Board of Supervisors adopts Resolution 21-
"Resolution Certifying 2020 County Maintained Road Mileage."

DISCUSSION: Section 2121 of the Streets and Highways Code for the State of California provides that, during the month of May of each year, each County shall submit to the Department of Transportation any additions or deletions from its mileage of maintained County Roads.

The total mileage of the maintained County Roads has not changed from the 2019 maintained mileage reported as 879.134 miles, but the roads in system have changed as indicated in Resolutions kept in the Public Works/Transportation Road Division files.
