ROAD DEPARTMENT

SUBJECT: Award aggregate materials and rock purchase to Sierra Cascade Aggregate in the amount of \$227,906.25, the lowest bidder meeting the requirements.

FISCAL IMPACT: Funding in the amount of \$227,906.25 will be from the current FY 2016-17 Road Operating Budget (122-1221).
