COUNTY COUNSEL-DRAFT ORDINANCE ON INDUSTRIAL HEMP

SUBJECT: Consider a draft ordinance proposing changes to Titles 1, 3, 6, and 19 of the Lassen County Code to allow the cultivation of Industrial Hemp, to establish a taxation rate for that cultivation, to exempt it from the County's right to farm protection, and to move the code provisions related to nuisance abatement from one title to another.

Supervisor Hemphill stated the next step would be to amend Title 19 and to separate hemp from cannabis. County Counsel Burns agreed that Title 19 needs

to be addressed. CAO Egan also agreed that the policy needs to move forward however staff needs additional direction and the process can take time. CAO Egan also informed the Board that County Counsel Burns has been working on revisions. County Counsel Burns stated a revised ordinance has been presented but hasn't seen any changes with state rules and regulations and Lassen County needs to be cautious. Director of Planning and Building Services Maurice Anderson addressed zoning. Extensive discussion was held. CAO Egan recommended the Board to table this item to the next scheduled Board of Supervisors meeting when all five (5) Board Members would be present. Supervisor Hemphill stated there would be a special meeting to be held on Tuesday, June 4, 2019, at 8:30 a.m. to continue discussion when all five (5) Supervisors would be present. The Board agreed.
