# PLANNING AND BUILDING SERVICES

#### CONTRACT AMENDMENT

SUBJECT: Amendment number six (6) to the contract with Willdan Engineering which increases the amount payable to Willdan from \$80,000 to \$140,000, and extends the term of the contract to June 30, 2024. FISCAL IMPACT: Increases general fund expense over a three-year period

by \$60,000.00 which is mostly paid for by building permit applicants for plan checks.

Assistant Planning and Building Services Director Gaylon Norwood informed the Board the amendment was for the contract held with Willdan Engineering and gave a brief overview of the services provided. Assistant Director Norwood explained how the contract fees were paid. Supervisor Hemphill asked if it would be cost effective to hire employees to fill the services provided by Willdan Engineering. Assistant Director Norwood stated Planning and Building Services had tried to recruit but was unsuccessful and it was less expensive to contract through Willdan Engineering rather than having employees to provide the services Willdan has. Director of Planning and Building Services Maury Anderson agreed with Assistant Director Norwood and informed the Board his office is often commended on the quick turn around time with plan checks. Discussion was held.
